#### **Birmingham Museum of Art**

The Birmingham Museum of Art is traveling their recent exhibition, "Expanding Darshan: Manjari Sharma, To See and Be Seen," which consists of thirtyone Asian sculptures from the museum's collection and photographs by contemporary artist Manjari Sharma concerning nine Hindu deities to the Phoenix Museum of Art from December 16, 2023, to April 14, 2024. The Rogers Historical Museum is beginning the reaccreditation process which will span the next year. Days will be filled with reviewing policies, completing projects in collections storage, and assessing the state of collections. In the meantime, a new Toys exhibit has been hugely popular, thanks to its opening the same weekend as the Barbie movie. In November, we look forward to showing a traveling exhibit from ExhibitsUSA, Working America, a photography exhibit highlighting the immigrant experience. The museum is partnering with the Ozark Literacy Council to add local context through stories and objects provided by their English language students. We are hopeful about this partnership and look forward to better integrating the immigrant story of NWA into our permanent exhibits in the near future. While preparing for a glassware exhibit next year, the museum also made the fun discovery of a variety of uranium glass in our collections. They were excited to make this discovery and will have fun planning how to best display our glass collections in the gallery.

#### **FLORIDA**

#### Heather Culligan Curator of Collections Tampa Bay History Center

After opening the third floor gallery renovations in June, Heather Culligan, Curator of Collections at the Tampa Bay History Center, has happily returned to doing the day-to-day of collections work! The first task, and continues to be ongoing, is to find homes in collections storage for the 300 items removed from the third floor. Most of the items have catalog records, but not surprisingly, several of the objects were never cataloged and now need brand new records. Finding space in collections for these items has been an interesting and challenging exercise in creativity, but a good one, as it has made Heather realize that many boxes and drawers can be reconfigured to store more objects.

Heather has also been working on cataloging the backlog of new donations, several of which have come in the last year, but were on hold due to the third floor renovations. She recently cataloged military documents from John Stanton Jackson who served in the Seminole Indian Wars and the Civil War, and cataloged ceramic pieces recovered from Fort Dade on Egmont Key from the late-19th century. Heather also rehoused previously cataloged objects, and designated a special storage area for rolled photographs and documents needing flattening. The Tampa Bay History Center also finalized the acquisition of over 5,000 historic postcards depicting scenes from the Tampa Bay area. The Reddick Collection, as it will be known, was the work of Richard D. Reddick, Jr. over a 30 year period. Attending postcard shows and perusing the internet, he created an extensive collection of rare and historic postcards that show incredible early scenes of Tampa and Florida history. Processing over 5,000 postcards will take time, but it will be the next big collection Heather will catalog over the next several months.

#### Kaitlyn Hof-Mahoney & Chloe Richardson Matheson History Museum

The Matheson History Museum in Gainesville, Florida is pleased to announce the acquisition of a large archive of materials from the Pride Community Center of North Central Florida. This archive documents LGBTQ+ history in our area and is a huge step forward in documenting the histories of underrepresented people in our community. The PCCNCF archive includes papers relating to historical local LGBTQ+ groups, including the papers of the Gainesville Area Aids Project and the AIDS memorial quilts created by their members in the 1990's. We look forward to researchers using this archive and hope to share these collections in our exhibits in the future.




#### GEORGIA Erica Hague Collections Manager Atlanta History Center

Our ongoing digitization project of museum materials has picked up steam. Our Project GRAs, Deb Wold and Jess Landers, have continued to make headway in the inventory portion, and have completed updating nearly 2,000 records. Jen Glaze, Project Registrar, has cleared 350 items updated with context added to the records. The inventory will be complete in December 2023, and the Registration portion will be completed in Spring, 2024. Our goal is 1,000 records made web ready. We are completing the photography portion on a rolling basis and released our first 50 or so records in conjunction with the federated search launch. A screenshot of some of our newest records, focused on the USCT are below, as accessible through our new federated search found here (https://www.atlantahistorycenter.com/ learning-research/search-the-collections) This new search tool, made possible by a grant via the Bloomberg Foundation, allows us to keep our various backend databases and have the public have one access point for them all. Of course, this means

that the 350+ records that were made web ready in the past now also need to be brought in line with our new standards, which I am working on slowly. We hope to reapply in the fall for an IMLS grant to continue this work in conjunction with topics covered in our traveling trunks.



We have also been busy with exhibits this summer. We opened "The Road to Good Taste" in June and at the beginning of August will open "Emmett Till & Mamie Till-Mobley: Let the World See," a travelling exhibition that will be with us through September 16th. Work is also underway to install our new exhibit at our Midtown Campus on Margaret Mitchell, which should open this winter. We are also preparing to deinstall one of our longtime exhibits, "Shaping Traditions," early next year—after a 20+ year run! Hope to see you all in Louisville for SEMC! A group of us Georgians have a great roundtable prepared on preserving institutional knowledge.

#### Marietta History Center, City of Marietta

The Marietta History Center has had a quiet summer, which for collections is always nice. We have had the quiet ended with the renovation of our first-floor bathrooms. These bathrooms, which haven't seen a major renovation since 1979, will finally become fully ADA compliant! Luckily, this renovation work does not affect the gallery spaces or collections storage. Work has begun with National Pan-Hellenic Council of Cobb County, to curate an exhibit on the Divine 9 within Cobb County. This exhibit will showcase artifacts and will reflect the history of each organization. Along with work on this exhibit, the MHC is working on an in-house exhibit exploring our large fashion collection.

#### **KENTUCKY**

#### **Kentucky Historical Society**

The Kentucky Historical Society opened a new exhibit spotlighting Kentucky's Women Veterans, Our Stories, Our Service, on June 10th. The display highlights women's stories through their belongings, oral histories, and experiences. Included is a timeline, recruiting office, statistic wall, and a video on the first all-female Honor Flight from Kentucky.



We recorded reflections of women veterans who could attend the opening: "To finally be honored... because most of us women that have gone, we really don't think anything of it. We just do what we did and go on about our lives. Then to have this happen and the Honor Flight happen it just took us aback. Like oh, wow, we really did that."

#### Kentucky Department of Parks

Jennifer Spence, Curator, reports that Kentucky State Parks finished several collections projects in the past few months. The Pioneer Museum in Carlisle, KY, received its final report from assessors hired through the Collections Assessment for Preservation Program. The museum's assessors were Mary Jablonski of Jablonski Building Conservation, Inc. (New York, NY)) and Heather White, Owner and Principal Conservator of LYLC Studio (St. Louis, MO). Jennifer and the staff at the Pioneer Museum are collaborating to carry out the conservators' recommendation. She and museum staff will check-in with their assessors in June 2024 to update the assessors on their progress. Jennifer recommends the CAP Program to any small or mid-size museum seeking a general conservation assessment or a re-CAP for those museums, which may have had an assessment in the past, but would like another evaluation years after their initial assessment.

Another significant program completed this season was building and artifact cleaning at Lincoln Homestead State Park in Springfield, KY. On park property are replicas cabins of Thomas' boyhood cabin and carpenter/blacksmith shop and the 18th century cabin where Nancy Hanks, Abraham's mother, lived as a young woman. That cabin, known as the Berry House, was moved to Lincoln Homestead State Park in the early 1940s. Jennifer worked with SERVPRO as they cleaned the ceilings, walls, and floors of the buildings. SERVPRO did not use chemicals to clean the cabins. After SEVPRO completed their work, Jennifer cleaned artifacts by HEPA vacuuming and dusting only. The park is developing and implementing a housekeeping plan, schedule, and checklists to maintain a clean environment in the cabins.

Kentucky State Parks are working on several collections projects, such as exhibit lighting at John James Audubon State Park, inventory at Waveland State Historic Site, and digitizing records at the central office in Frankfort.

#### The Kentucky Museum, Western Kentucky University

IMLS has awarded it a grant for \$37,000 to help it rehouse its 330+ quilt collection. The funding will underwrite the purchase acid-free boxes, tissue, and shelving as well as relocate and merge storage of all large flat textiles into a single location at the Kentucky Museum. This project is part of a larger study that is evaluating the use of spaces vacated by Library Special Collections after its move this summer to the main library building on the campus of Western Kentucky University.

#### **Natchez National Historical Park**

Museum Curator Cheryl Waldrep reports that Natchez National Historical Park hosted two curatorial interns this summer who have participated in a variety of helpful projects including inventory, rehousing boxed objects, environmental monitoring

such as light readings, data logger collection, and integrated pest management. **Francis Harte** came to the park from New York and Kristyn Merritt is local to Natchez, Mississippi. Both are part of the American Conservation **Experience Cul**tural Resources



Diversity Internship Program and have been an awesome addition to curatorial staff this summer. The park will be announcing permanent curatorial positions in the coming months.

The High Point Museum's Summer Collections Management Intern, Bonnie Showfety, is wrapping up her project in early August. Bonnie has spent the summer conducting oral history interviews with residents of Highland Mill Village, a National Register district and former cotton mill village. Bonnie has used the interviews and other items from the museum's collection to create a walking tour of the neighborhood for the museum's STQRY app. A highlight of the summer was taking a tour of the former mill complex, now used by Cisco Home to manufacture and distribute furniture. Bonnie is a graduate of High Point University and works at the North Carolina Transportation Museum. Registrar Corinne Midgett has really enjoyed working with Bonnie and wishes her well as she starts graduate school this fall!
